4. MINUTES – TO CONFIRM AS A CORRECT RECORD THE MINUTES OF MEETING HELD ON 25th FEBRUARY 2026.

5. CHAIR'S ANNOUNCEMENTS

6. CLERK'S REPORT AND MATTERS ARISING FROM MINUTES OF MEETING HELD ON 25th FEBRUARY 2026.

Cllr Clarke has contacted the clerk with reference to a map of the waste bin locations within the town, to consider the possibility of replacing the coloured plastic bins for the smarter black bins. This was first mentioned several years ago but was not followed through. It is not something that is included in this year's Council Action Plan and neither is there a budget for it, but it could be included in next year's budget, to replace a small amount per year, in areas to be selected by Council, if approved.

Preparations for the Medieval event are going well, with a good selection of stalls, music, games and activities already confirmed.

The past festival organisers have contacted Council to confirm that the committee is now disbanding and would Council like to take on the festival going forward, before any accumulated funds, are donated to charities. The offer was politely rejected, so the donations can go ahead.

The Clerk has received 3 x expressions of thanks from the community, 1 x for a grant application, 1 x for the Pump Track and 1 x for the refurbished Stocks. All appreciation is gratefully received!

7. TO EXPRESS THANKS TO THE RAPID RELIEF TEAM AND EVERYONE ELSE THAT TOOK PART IN THE TOWN CLEAN UP ON 8TH APRIL 2026.

Members agreed.

8. TO DISCUSS ANY REPAIRS, URGENT OR OTHERWISE, REGARDING THE WELLS.

Members agreed that urgent repairs should be addressed immediately and an independent report be sought regarding future maintenance.

Cllrs Eddolls & J Davies have carried out a fix on the small well.

9. **TO NOTE THAT CLARK & KENT, COMPLETED WORK ON THE INSTALLATION OF A BIKE TRACK ON KING GEORGE'S FIELD, AT END MARCH 2026. IT IS NOW IN USE AND FEEDBACK HAS BEEN VERY POSITIVE.**

10. **TO DISCUSS THE POSSIBLE FUTURE INSTALLATION OF A BENCH AND LITTER BIN SURROUNDING THE BIKE TRACK.**

Members commented that litter may be a problem. The Clerk said that once the track had 'settled', Council will look to install a waste bin and a perch bench.

Members noted and the Clerk confirmed a date of 5th May 2026 for the extra paving.

14. **TO NOTE THAT THE REFURBISHED STOCKS HAVE BEEN RETURNED & INSTALLED ON THE GREEN.**

Members noted and thanks were given to those involved in the process.

Members agreed on the grass verge to the front right of The Stocks, where 'readers' would be on the hardstanding.
